

### CONTRACT FORM - RENDERING OF SERVICES

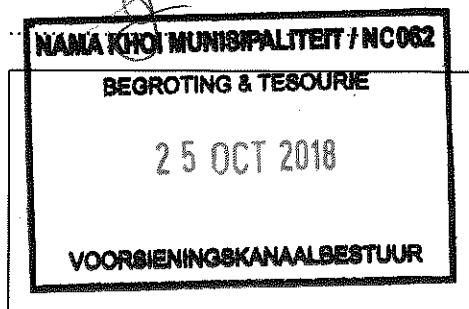
