

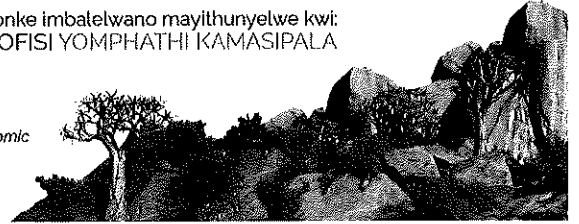

The bid number on the cover page is incorrect. It is reflected as BID/NC062/23/2026-2027 and should be BID/NC062/23/2025-2026.

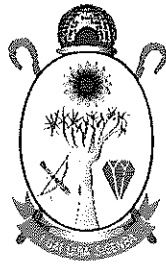
The MBD 1 form incorrectly refers to Khai-Ma Municipality. This should be amended to Nama Khoi Municipality.
